## **8. ENTRIES AND ENTRY FEE**

Applications for entry must be made on the official entry form.

Applications must be approved by the rider's FMN and must reach the organizer before 24.08.2022 midnight.

Riders must be in possession of a valid national license and starting permission.

The entry fee for this FIM Mini GP Alpe Adria Series is € 750,00 + VAT (22%) per rider for the whole season. The amount for the paddock facilities incl. electricity, water (with toilets/showers) and waste (no tyres or oil) is included.

Wild Card are allowed to apply for the event at the cost of € 200,00 + VAT (22%) per rider.

All entry fees must be paid via bank transfer within the registration date including name and class at the following: ALPE ADRIA MOTORCYCLE UNION: IBAN: IT07N0306909606100000173811 BIC: BCITITMM Causal: Entry Fee FIM Mini GP Alpe Adria Series "Name Surname".

There is no transponder rental fee.

#### 9. ADMINISTRATIVE CHECK

The administrative checks will take place on Saturday, August 27<sup>th</sup> from 10:00 to 12:00 and Saturday, August 28<sup>th</sup> from 7:00 to 8:00.

## **10. TECHNICAL INSPECTION**

No rider or machine is permitted onto the track unless he/it has passed the technical inspections.

The official technical inspections will be held on Saturday, August 27<sup>th</sup> from 10.00 do 12.00 and Sunday, August 28<sup>th</sup> from 7.00 to 8.00.

During these inspections the helmet and clothing must be presented for inspection.

#### 11. PRACTISING

It is strictly forbidden to ride machines on the circuit outside the official practice periods according to the official timetable!

Supplementary free practices on previous days (organized by the circuit owner) are not part of this event.

#### 12. RIDERS BRIEFING

A compulsory briefing will be held on Saturday 28.8.2022 at 8.00 on the starting grid. All riders must be present and must be accompanied by a parent, guardian, or team manager.

#### 13. RACES

## 14. PRIZES

The Prize-giving ceremony will be held immediately after the event with the first three qualified riders at the podium. The final prize-giving ceremony will be held on **Sunday**, **August 28**<sup>th</sup>, immediately after the last race finishes at the podium.

#### 15. PROTESTS

All protests must be made in accordance with the FIM Europe Disciplinary and Arbitration Code and be accompanied by a fee of € 350,00.

#### 16. ENVIRONMENTAL REGULATIONS

Washing of motorcycles is only permitted without any chemical substances and in an area specially designed for this purpose. Pouring or throwing away used oil or any other petrol waste outside the marked boxes is forbidden. It is compulsory for riders and their teams to use the environmental mats (size 160x100 cm) while parking, doing repair works, refuelling and under the waste boxes. The environmental mat must have an absorbent upper part and an impermeable bottom part. Riders are not allowed to spill out any waste water in the car park out of their trailers and caravans. It is only possible to do this at a place that is set up for this purpose. It is forbidden to damage the flora and fauna by inappropriate treatment or parking. These regulations are mandatory. Any infractions of these rules may be financially penalised by up to 333 €.







#### 17. FUEL

There will be no fuel supplied by the organizer at the paddock.

## **18. INSURANCE**

By endorsing the application form for entry, the FMN of the rider certifies that the rider is insured in accordance with the FMN requirements and declares that the rider is able to compete in the respective class.

In conformity with Art. 110.1 of the Sporting Code, third party insurance in respect of riders and passengers covering accidents occurring during the event including practices will be the responsibility of the organizer.

This insurance includes a guarantee of € 170.000.

The organizer disclaims all responsibility for damage to a motorcycle, its accessories and components arising out of an accident, fire or other cases.

### 18. RENUNCIATION OF ANY RECOURSE AGAINST SPORTING AUTHORITIES

Apart from the requirements of the FIM Europe Sporting Code, riders and passengers by participating, renounce all rights of appeal against the organizer, his representatives or agents by arbitration or before a tribunal or any other manner not foreseen by the FIM Europe sporting Code for any damages for which they could be liable in Consequence of all acts or omissions on the part of the organizer, his officials, Representatives or agents in the application of these regulations or contributed to or Arising out of their actions.
