The competitors own sponsors or any other advertising must not cover ANY part of the riding number race jacket (except the shoulder straps).

Front Fork Covers (Speedway): Supplied by the organisers: NO

NOTE – if the organiser suppliers competitors with event sponsored front fork covers (for any FIM Europe Speedway Championship event) competitors must fix them securely to their motorcycles during practice, racing, the prize-giving ceremony and any press conferences where their motorcycle may be photographed,. The competitors own sponsor or any other advertising material must not cover any part of the front fork cover.

<u>Environmental Mats:</u> Please note that for ALL Track Racing events, competitors must provide and use an environmental mat per motorcycle. The use of environmental mats <u>is COMPULSORY</u> If competitor's use a generator or other similar petrol/diesel devices within their pit area, then they too must be placed on an environmental mat to ensure that no spills or leakage gets into the ground.


