## **Protests and appeals:**

Any person or group of persons - rider, passenger, entrant, manufacturer, official, etc., recognised by the Referee/Jury and concerned by a decision taken under authority of the Referee/Jury, has the right to protest against that decision before the Referee/Jury, except in the case of statement of fact. Protests against the eligibility of a rider, passenger, team or a motorcycle entered, must be made before the start of the official practice. Protests against results must be presented to the Referee/Jury within 30 minutes following the publication of the results. An appeal may be made against a decision of the IReferee/Jury to the Court of Appeal of the FMNR. All protests to the Referee/Jury must be made in accordance with the requirement of the Disciplinary and Arbitration Code of the National Sporting Codes and be accompanied by a fee of 50 Eur returnable if the protest is justified or forfeited if the Disciplinary body considers the protest to be groundless, or if it is withdrawn without a hearing.
