Protests and appeals:

Any person or group of persons - rider, entrant, official, etc., recognized by the Referee/Jury and concerned by a decision taken under the authority of the Referee/Jury, has the right to protest against that decision before the Referee/Jury, except in the case of statement of fact.

Protests against the eligibility of a rider, passenger or a motorcycle entered, must be made before the start of the official practice.

Protests against results must be presented to the Referee/Jury within 30 minutes following the announcement of the results.

An appeal may be made against a decision of the Referee/Jury to the Court of Appeal of the FMNR.

All protests to the Referee/Jury must be made in accordance with the requirement of the Disciplinary and Arbitration Code of the National Sporting Codes and be accompanied by a fee of € 50 (equivalent amount in local currency) returnable if the protest is justified or forfeited if the Disciplinary body considers the protest to be groundless, or if it is withdrawn without a hearing.

Protest in priziv

Vsak voznik, društvo, ki sodeluje na prireditvi, in na katerega se nanaša odločitev sodnika ali žirije, ima pravico vložiti protest. Protest ki se nanaša na ustreznost vozila ali voznika sprejetega na prireditvi, mora biti vložen pred prvim treningom. Protest proti rezultatom mora biti vložen v roku 30 minut po razglasitvi neuradnih rezultatov. Ob vložitvi protesta se plača kavcija, višina le te znaša za voznike 50 EUR (plača se ustrezna vsota v lokalni valuti). Proti odločitvi sodnika ali žirije se lahko vloži priziv, skladno z Športnim pravilnikom nacionalne zveze voznika. Ob vložitvi priziva je potrebno vplačati kavcijo, določeno s športnim pravilnikom nacionalne zveze.
