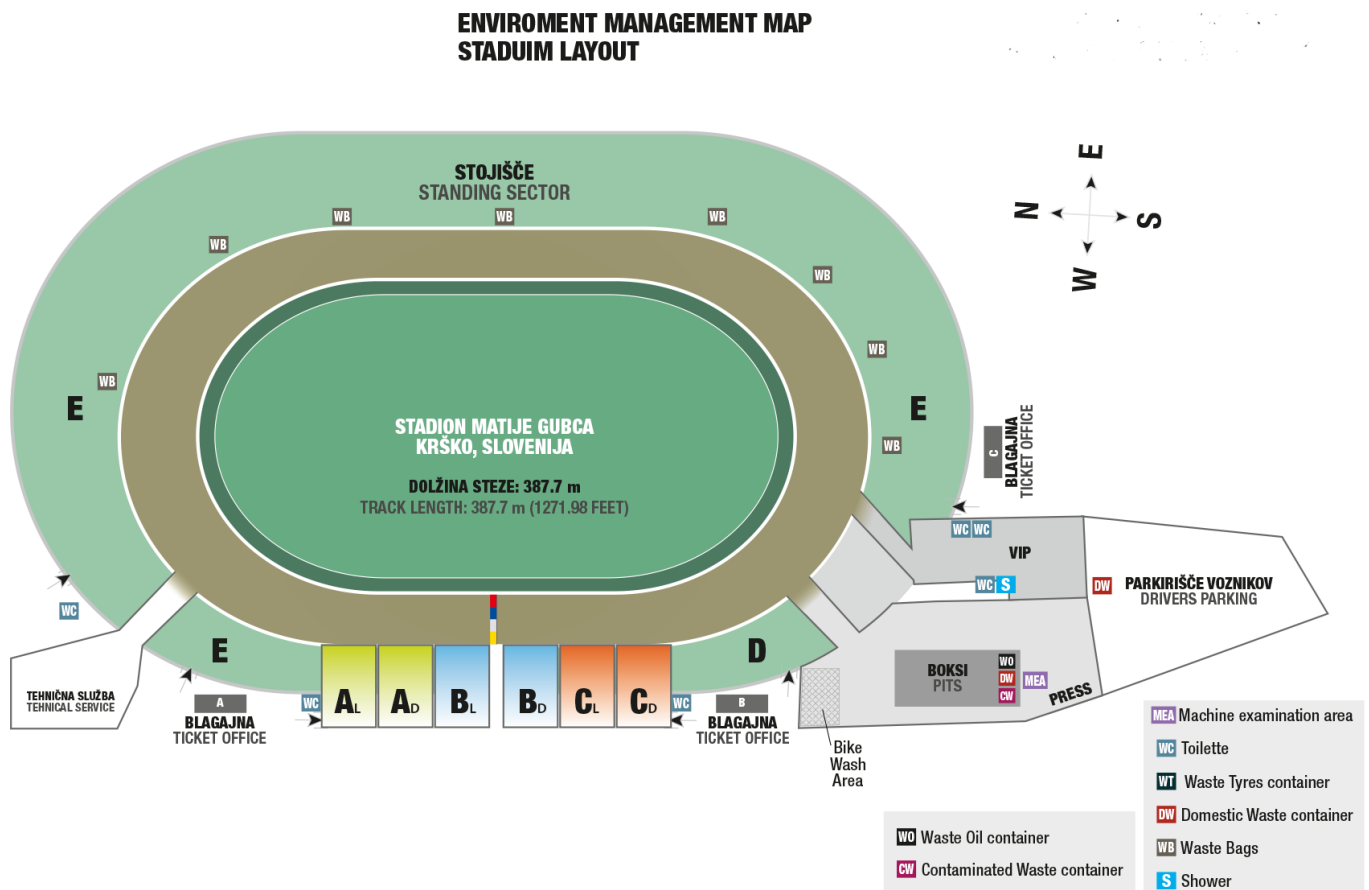
Environmental Management Map:
